Dear Chapter Presidents:

It is time to nominate three outstanding alumni from your chapter to be considered for the **2024 “Outstanding Young Alumnus of the Year Award,” “Outstanding Alumnus of the Year Award,” and “Ms. SCSUNAA Queen.”**

Enclosed are the award criteria, nomination form, transmittal form, packet checklist and a list of amenities each winner will receive. The packet will be accessible via the SCSUNAA website. All national alumni members should have access to this entire document. The Awards Chairperson must receive via UPLOAD ONLY the completed packet by 11:59pm ET on January 31, 2024. All packets should not exceed 12 total pages (including photos and supporting documents), should be neatly prepared, well organized and scanned into one complete packet and uploaded via the website.

Award recipients must be able to attend the 2024 Alumni Weekend/Banquet, the 2024 convention/annual meeting in Charleston, SC, July 25 -28, 2024 and the 2024 Homecoming parade/game (Date TBD). All award recipients will be presented and/or crowned at the Alumni Banquet on May 2024. Only the Queen will take part in the halftime activities at the homecoming game, but all award recipients will be featured in the homecoming souvenir journal and ride on the awardee float. Please see the attached list of amenities for more details.

Chapters are encouraged to financially assist their winning nominee(s) with accommodations for Alumni weekend and/or other activities to the extent that they are able. Remember, as our fellow alumni are recognized and highlighted, so is your chapter.

Chapters are strongly encouraged to nominate only ONE alumnus per category. Current award recipients are not eligible for consideration for any other award category for a minimum of two years. For example, a 2023 award recipient would not be eligible for consideration for a new award category until 2025. Packets received after the deadline of January 31, will not be reviewed. The selected award recipients will be announced at the National Alumni Council meeting in February 2024.

2024 AWARDS CRITERIA

The nominees for all awards should meet the following criteria. All award packets must be accompanied by the Nomination Form and the Awards Transmittal sheet for each nominee. Each nominee should review and follow the **Packet Check List** to insure completeness. Nominations must be received via UPLOAD Only by January 31, 2024.

NOTE: Current National Officers and Award Committee Members are ineligible for nomination.

CRITERIA for Outstanding Alumnus/Young Alumnus of the Year and Ms. SCSUNAA Queen

The nominee should have:

1. Graduated between 2003 – 2023 to be eligible for the “*Outstanding Young Alumnus of the Year Award*” or before 2003 for the “*Outstanding Alumnus of the Year Award*”.
NOTE: There is no year of graduation restrictions applicable for the SCSUNAA Queen!
2. Been an active, financial member of a local chapter for at least three consecutive years and should be financial when nominated.
3. If an **At-Large Member** – active/financial with the National Alumni Association for three consecutive years. Verification of your financial status will be confirmed by the Membership Committee when your packet is submitted.
4. Held an office or served as a committee chair in **your** local alumni chapter.
5. Attended at least two (2) National Alumni Conventions.
6. Contributed financially to South Carolina State University within the last three (3) years.
7. Made contributions to his/her profession, community, religious, civic clubs, sorority/fraternity, or other organizations.

The nominee for Outstanding Young Alumnus, Outstanding Alumnus and Ms. SCSUNAA Queen must submit:

1. A letter of recommendation signed by the Chapter President or Chapter Vice President. An At-Large must have a signed letter from a National Officer or a Chapter President.
2. An Essay/Letter of Interest (300 words or less) on why you should be selected in your category.
3. A Nomination Form (enclosed) and supporting documents reflecting the nominee’s contribution to the following:
 - a. The local alumni chapter.
 - b. South Carolina State University National Alumni Association.
 - c. South Carolina State University and (i.e., Foundation, Band, Athletics, etc. and/or other support of the University).
 - d. Professional, Civic, Community.
4. Documentation of attending at least two (2) National Alumni Conventions.
5. Documentation of holding/have held an office or served as a committee chair in the local alumni chapter.
6. Documentation of contributing financially to South Carolina State University within the last three (3) years
7. A personal data sheet, vita, or resume and a high-quality photograph:
Personal data sheet must include personal, educational, and professional background; civic and community involvement; and organizational affiliations.

- ✓ Did you include an essay/Letter of Interest of why you should be selected in your category?
- ✓ Did you list your contributions (service, not money) to your local Chapter, SCSUNAA, S. C. State University and your local community?
- ✓ Did you include a resume with a high-quality professional photograph?
- ✓ Is your packet 12 pages or less?
- ✓ **Is your entire packet scanned and able to be uploaded into one document?**
